3.11 Indigent Policy

Section 2 of the policy will be adjusted as follows:

"Households where verified total gross monthly income of all occupants over 18 years of age does not exceed twice the government pension grant or such other amount as the council may from time to time determine, qualify for a subsidy on property rates and service charges for sewerage and refuse removal, and will additionally receive 6kl of water per month and 50kWh of electricity per month free of charge."
